

# TRADE BOARD LTD. FREQUENTLY ASKED QUESTIONS

1. IN ADDITION TO YOUR EXPORT REGISTRATION WITH JAMPRO, DO YOU REQUIRE ANY OTHER EXPORT LICENCE FROM A GOVERNMENT AGENCY?

Yes, the export of some specified products requires an export licence from the Trade Board Limited.

2. WHAT ARE THE PRODUCTS THAT REQUIRE AN EXPORT LICENCE FROM THE TRADE BOARD LIMITED?

An export licence from the Trade Board Limited is required for the following products:

Scrap Metal (incl. Scrap Batteries)	Plasma (in any form)
Scrap Gold/Silver	Wood (Lignum Vitae and log wood only)
Coffee	Motor Vehicles
Ammunition (explosives and firearms)	Jewellery (excluding those from earth metals)
Brown Sugar

# 4. WHICH AGENCY OF THE GOVERNMENT OF JAMAICA SHOULD BE CONSULTED TO VERIFY ITEMS REQUIRING AN IMPORT LICENCE?

The Trade Board Limited is also responsible for the issuing of import licence for selected items, as outlined below:

#### 5. WHAT IS A CERTIFICATE OF ORIGIN?

The certificate of origin is an important international trade document attesting that goods in a particular export shipment have been wholly obtained, produced, manufactured or processed in a particular country in accordance with the prescribed rule of origin.

# **Certificate of Origin**

A document with information on where a product was manufactured, assembled, and its destination.

## 6. IN WHAT CONTEXT ARE CERTIFICATES OF ORIGIN ISSUED?

A certificate of origin may be issued in the context of preferential trade agreements, which enable exporters to benefit from tariff exemption or reduction for eligible exports; OR it may be requested by the Customs Administration, importers, freight forwarders or banks.

### 7. HOW DO YOU APPLY FOR A CERTIFICATE OF ORIGIN?

To apply for the certificate of origin, exporters are required to:

- Complete a product analysis form for each product to determine the origin criterion. You may contact the Trade Board Limited to obtain the form.
- Submit the completed form along with supporting documents, i.e., Import Entries (C87 Forms) and supporting invoices to the Trade Board's Certification Unit
- iii. An officer from the Trade Board Limited will visit your facility to verify the production process
- iv. Exporters will then be advised in writing whether or not the product qualifies for preferential treatment (tariff exemption or reduction) and the origin criterion, if applicable.

NB: All exporters making application for a certificate of origin must be duly registered with JAMPRO

## 8. HOW DOES AN EXPORTER QUALIFY FOR PREFERENTIAL TREATMENT?

The products manufactured by an exporter will qualify for preferential treatment (tariff exemption or reduction) by meeting the prescribe rule of origin, as outlined in a particular trade agreement.
