The Government of Jamaica (GoJ) has received financing from the World Bank toward the cost of the Foundations for Competitiveness and Growth Project, and intends to apply part of the proceeds for consulting services.

The Consulting Services ("the Services")

The Government of Jamaica (GOJ) is seeking to engage the services of a team of Consultants to develop an Enterprise Content Management (ECM) System for Companies Office of Jamaica (COJ) to streamline its case and document management, which will translate into the availability of better data to promote enhanced management decision making in real time and provide better information for the private sector to make business decisions and projections.

The Consultant will be required to:

- a) Prepare an ECM System Design and Architecture;
- b) Customize, configure and install an ECM System;
- c) Undertake migration of existing data to the new ECM;
- d) Prepare End User and IT Administrator Training Manuals for the ECM System; and
- e) Provide training to relevant stakeholders.

The anticipated duration of the assignment is eleven (11) months.

The shortlist will contain five (5) to eight (8) firms, with demonstrated experience in the field of the assignment.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" July 2016 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a subconsultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Quality and Cost Based Selection method of the World Bank Procurement Regulations 2022 and will be specifically set out in the Request for Proposals.

Expressions of Interest (EOIs) must be uploaded on or before October 6, 2022 at 11:45pm. Submissions will be accepted via the Government of Jamaica Electronic Procurement Portal (www.gojep.gov.jm). No hard copy submission will be accepted.
