OBJECTIVES OF THE CONSULTANCY

To conduct a review of the existing Industry Skills Upgrade Strategy (2021) with an emphasis on determining if the skills and knowledge identified as critical in addressing skills gaps in the sector were addressed by current skills development programmes facilitated under the GSS Project; and to indicate if any, new skills gaps inhibiting Jamaica's ability to scale into higher value-added segments of the Global Services Sector; and

To write an updated strategy which will outline the skills and knowledge areas required to grow the industry into higher value-added segments during the next 18 months (that is from July 2023 to December 2024).

QUALIFICATION AND EXPERIENCE

The consulting firm must ideally have:

- Five (5) years' experience working with the private sector, management, or strategic consulting
- Experience working on similar projects related to industry upgrade or industry/sector transformation would be an asset.
- Experience working in Regional and/or Global jurisdictions required.
