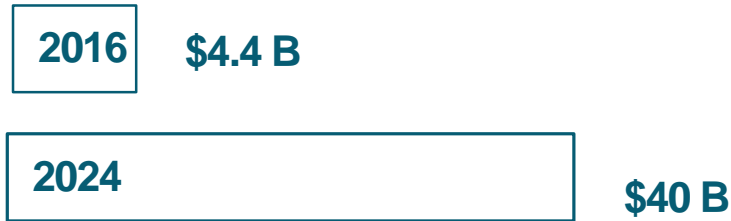

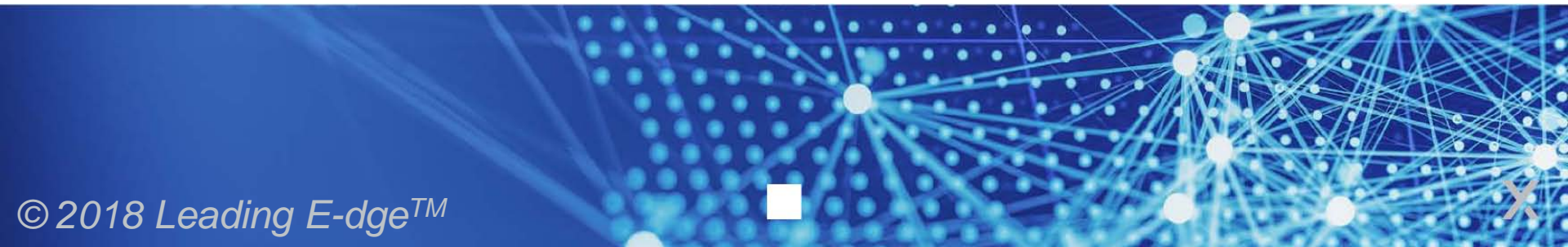
GLOBAL FLOW OF OUTSOURCED LEGAL ACTIVITIES



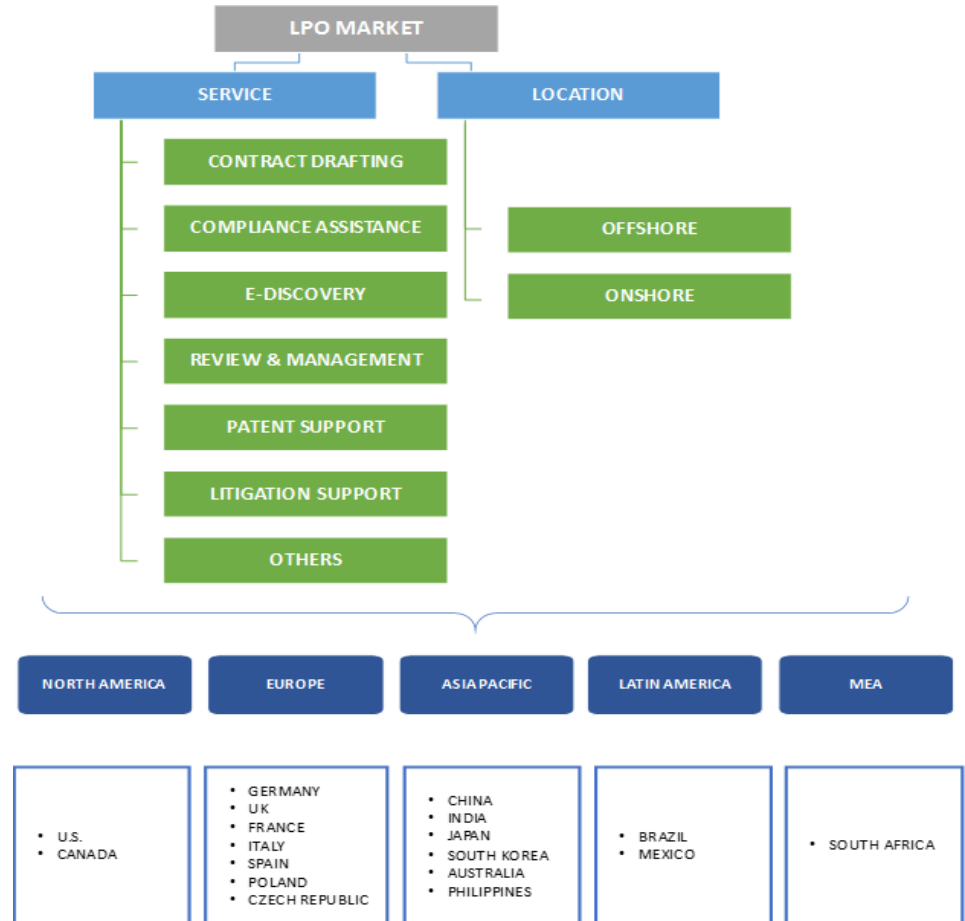

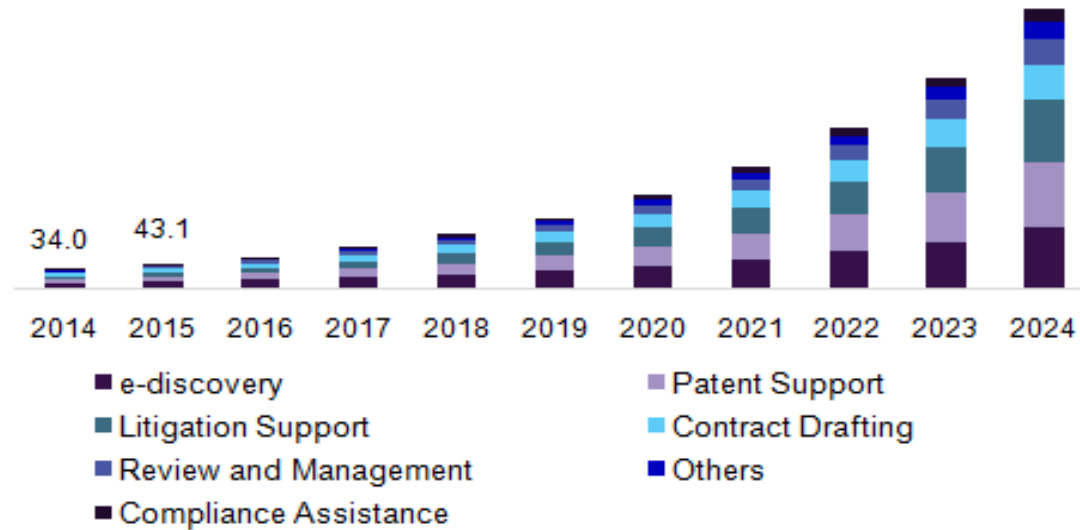
Estimates vary, but reasonable expectations see the global LPO market growing from \$4.4B in 2017 to \$40B in 2024 – a 40% compound annual growth rate.

OFFSHORE.



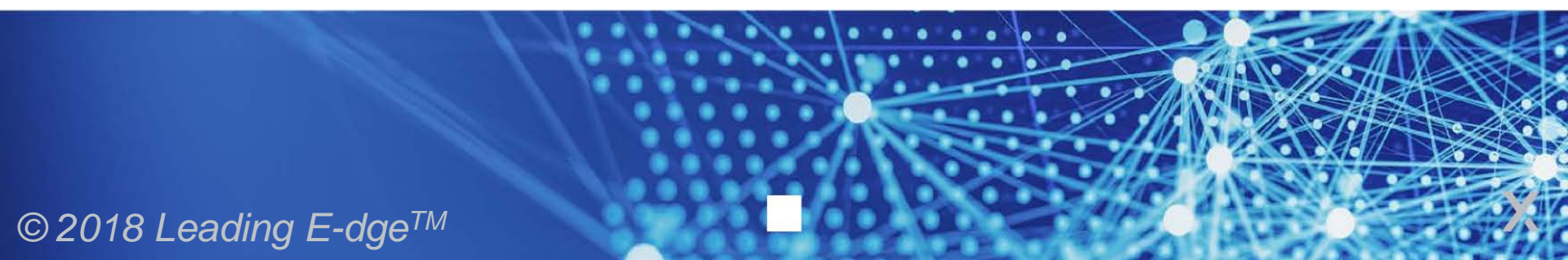

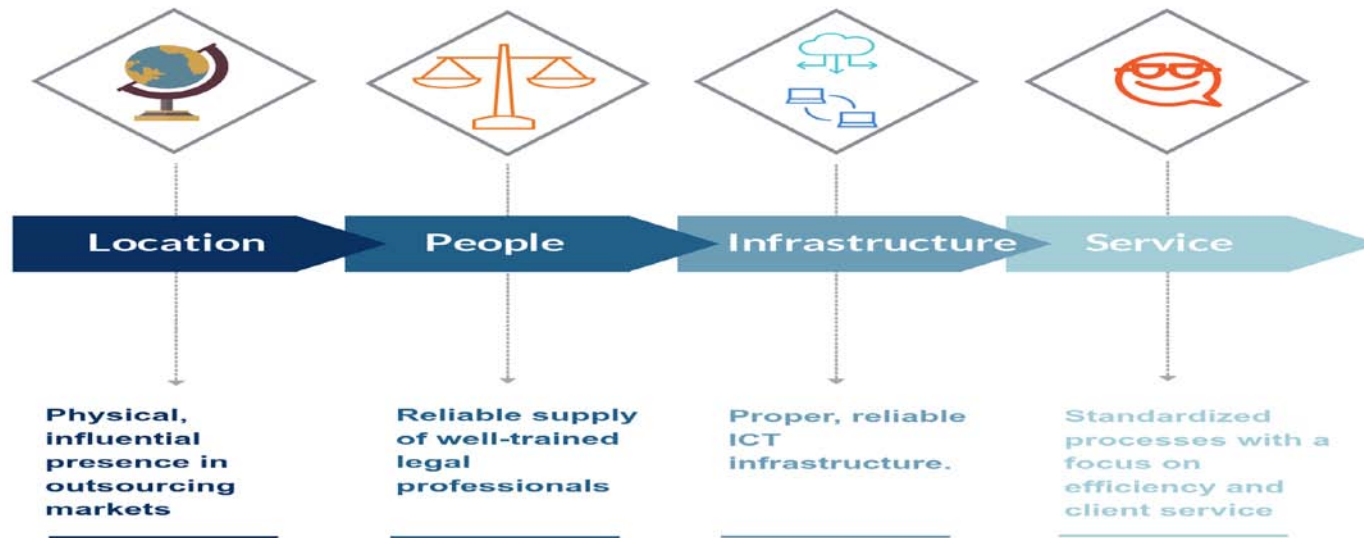

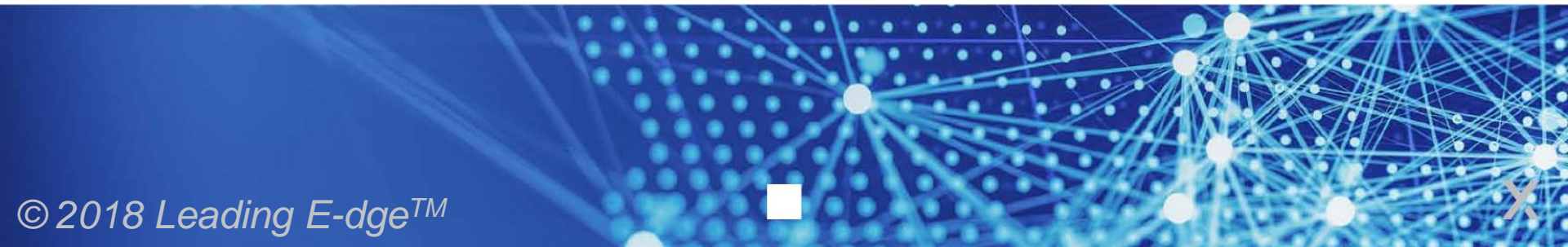
